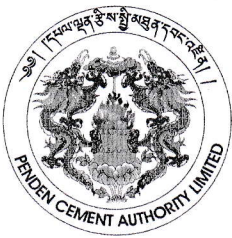

  3. Order will be placed from time to time depending upon our requirement and you should be able to supply the goods within 15 (fifteen) days from the receipt of order.
  4. 2% of the quoted value is to be deposited as EMD in the form of Demand Draft/Cash Warrant prepared in favor of "Penden Cement Authority Limited", payable Bank of Bhutan, Gomtu. Offer without EMD will not be accepted. Any Bids accompanied by a form of Bank Guarantee (BG). The EMD will bear no interest.
  5. 10% of the quoted value to be deposited as Security Amount by the winning bidder and will be kept with PCAL till the contract period without any interest. The same will be refunded to the party after successful completion of the contract.

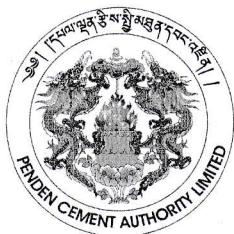
