- 2. Fill the Price bid submission form and submit your bid with signed, name, contact number and CID/Voter card attached and mail to tc@pendencement.bt on or before 26<sup>th</sup> July 2024, 02:00 PM (BST) and shall be opened on same day at 02:30 PM (BST).
- 3. You are requested to quote the rate as per the price bid form.
- 4. EMD of Nu/INR. 100,000 (One lakh) only should be deposited in our PCAL's Account number: 101731083 Bank of Bhutan Ltd, Gomtu Branch or RTGS/INR Remittance inward (only for Indian Suppliers) from State bank of India to Bank of Bhutan Ltd, Account No: 11128915571 IFSC-SBIN0001447 to Beneficiary Penden Cement Authority Ltd. Account No: 101731083 Bank of Bhutan Ltd, Gomtu Branch, and should attached the deposit slip.
- 5. Bid without a valid EMD shall be rejected. EMD of unsuccessful bidders shall be refunded after the finalization of the bid only.
- 6. The EMD shall be forfeited if the winning bidder withdraws the bid.
- 7. Payment shall be in cash/cheque to PCAL's account and need to be made within a week of time after issuance of letter of acceptance (LOA).
- 8. The goods shall be removed by the successful bidder within a month after issuance of letter of acceptance (LOA).
- 9. 3% Tax (Indian), 2% Tax for (Bhutanese) will be deducted from the contractor bill and remitted to the Royal Government of Bhutan Revenue Account as per the directive of the Royal Government of Bhutan. The Finance and Investment department will furnish a TDS certificate on your requirement.
